### **INFORMATION WE MAY COLLECT**

As do many other websites, FSP may use aggregate data compiled by cookies to provide us with information about traffic to our site. Cookies are small pieces of information that some websites store on your computer's hard drive when you visit a site. Collecting this information does not allow FSP to personally identify you. While many browsers automatically accept cookies, you have the option to set your browser to reject cookies or to alert you when cookies are being sent. You may access the information on the FSP site without having cookies enabled in your browser.

We may collect and log the IP address of all visitors to the FSP site. IP address may be collected and logged in order to help us gather aggregate information to help us monitor the effectiveness of the FSP website. IP address are not collected and logged as a means to identify any visitors to our site.
